- The address and mortgage number of any mortgages, loans and/or secured lines of credit on the property. *Please provide a copy of your most recent statement.*
- Your most recent realty tax bill If you are on a pre authorized payment plan with the municipality, please inform the tax department of the impending sale and have your plan cancelled effective the day of closing.
- 3. Original or copy of the building location survey for the property, *especially* if stated for in your Agreement of Purchase and Sale.
- 4. If your property is heated by oil or propane, please advise the capacity of the tank(s) and provide the name and contact information of your fuel company. You will be responsible to ensure that the tank(s) are filled on the date of closing.

You are responsible for all payments of taxes, utilities, mortgages, and condominium fees (if applicable), up to and including the day of closing. You should contact all of your utility companies and inform them of your move and provide the utility company with your new address so that they can forward any final bills directly to you.
